## Minutes – 290<sup>th</sup> Annual Meeting United Church of Christ, Congregational Burlington, Massachusetts February 5, 2023

**Opening Remarks and Prayer:** Moderator Sally Willard opened the meeting by welcoming members and guest and called the meeting to order. This meeting was hybrid being held in the sanctuary and on zoom following a light lunch in Sewall Hall.

Sally explained the voting procedure, and Michael Lewis had a poll that would be displayed for those online people to vote through. Sally introduced Reverend Ed Koonz to open us in prayer followed by Brian leading us in a hymn, This Little Light of Mine.

**Certify Meeting Quorum:** Acting as Clerk Deana Tredeau certified that we had more than the required 10% of membership, we had more than 20%. (45 of 210 members) and that we had a quorum.

**Remembrance of Members and Friends Who Died in 2022**: The clerk read the names of the former member and friends of the congregation who died during the past year.

**Approval of Minutes**: A motion to approve the minutes of the 289<sup>th</sup> Annual Meeting was Made, Seconded, and Approved.

A motion to approve the minutes of a Special Congregation Meeting held on May 1, 2022, was Made, Seconded, and Approved.

**Acceptance of the Annual Reports**: A motion to accept the 2022 Annual Reports of the Church Officers, Boards and Committees was Made, Seconded, and Approved unanimously.

**Nominating Committee Slate:** Michael Lewis reviewed the nomination committee slate, noting that there are several vacancies. He encouraged people to stretch our comfort level and help the church by filling these vacancies. The slate of officers was read and different jobs were described encouraging all to consider volunteering for spending 24 hours a year serving in one of the positions. A motion to accept the slate of boards and officers for 2022 was Made, Seconded, and Approved unanimously.

**Operation Budget** -Mark Flecchia reviewed 2022 and presented the 2023 budget as shown in the Annual report with \$23, 164.16 deficit. Fundraising participation was requested to help solve the deficit. A Motion to approve the 2023 budget was Made, Seconded, and Approved. Mark would like for someone to consider a future position of Treasurer which he has held for many years and does a wonderful job.

**Emergency Fund** – Sally Willard asked that the Parish Council be empowered to spend up to \$5,000 from the Endowment fund in case of emergency. After discussion it was recommended and approved to increase the emergency fund to \$10,000. A Motion was Made, Seconded, and approved increasing the Emergency Fund to \$10,000. This action is recommended every year to avoid having to call an emergency special congregational meeting and to allow the Trustees and Church to deal with.

**Church Goal for 2022** – Sally Willard and Rev. Ed Koonz presented the proposed the Church Goal for 2023

#### Church Goal for 2023

In 1732 our church was built on a parcel of donated land called Forest Field Hill. We honor the determination, faith, and sacrifices of our forebears who have sustained this church for 291 years.

God is still speaking! Our goal for 2023 is to grow the church. We will create purposeful opportunities that invite, reach, and touch a variety of people from diverse backgrounds, regardless of where they are on their life's journey. Jesus reminds us to live our faith in all aspects of life. We are challenged by Scripture to meet the spiritual and physical needs of people both within and outside the church walls.

Church can be in a sanctuary up on a hill, in a park, a homeless shelter, or a land far away. As people of faith, we will use our many gifts to spread the light and grow the church, not only for ourselves but for the generations who will follow us.

Matthew 5:14-16, "You are the light of the world. A city built on a hill cannot be hidden. People do not light a lamp and put it under the bushel basket; rather, they put it on the lampstand, and it gives light to all in the house. In the same way, let your light shine before others, so that they may see your good works and give glory to your Father in heaven."

The Motion was Made, Seconded, and Approved unanimously to accept this Goal.

# Other Business That May Legally Come Before the Congregation and Remarks for the Good of the Parish included:

Brian Gionet, our new Director of Music Ministries expressed his delight to be with us and requested assistance with upstairs cleaning.

Appreciation was expressed for the many years of service of Paul and Jane Raymond and that their presence is missed this year.

Sally Willard was thanked for her service as moderator through the difficult years of the COVID pandemic.

	Question: When Revision inspects the solar panels each year, will they also inspect the roof and cover any problems with the roof?
	<b>Answer:</b> Yes, for the first 10 years of the installation warranty. To date, Revision has been very responsive to maintenance requests.
	Question: What about the past/current problems with the leaky roof?  Answer: The roof is no longer leaking. Revision has committed to paying for half of the cost for repainting the ceiling in the Sewell Hall.
	Conrad Fong thanked Dave Ierardi for his ongoing management and oversight of the Solar Panel project. The congregation applauded Dave for his efforts.

#### SETTLED PASTOR SEARCH COMMITTEE ANNUAL REPORT FOR 2022-2023

The Settled Pastor Search Committee began its work in July of 2022. The following members Anna Karwan, Jan Costa, Caitlin Spearson, Julie Lewis, Carol Downing, Samantha Flecchia, and Laura Nowell, were commissioned by the congregation on September 11, 2022. In August 2022 we began the search for a settled pastor by working on updating our Local Church Profile which is instrumental in supporting the calling and discerning of future pastoral leadership.

In addition to using the guidelines of the Southern New England Conference of the UCC, the committee was tasked with helping our congregation determine answers to 3 questions: Who Are We Now? Who is Our Neighbor, and Who is God Calling Us To Be?

Many resources were available to support our updating of the Local Church Profile including: The CAT (Holy Cow!") Survey of the congregation's views, small group discussions of people's desires for the future of our church, Mission Insite information including our church's 11 Year Report that includes demographics on our church and community. Working with these resources we strived to incorporate our Vision Statement and 2022 church Goal.

In order to achieve our goals, the search committee met in person and through Zoom approximately once a week except for holidays. Our Profile was posted for candidates to review in January 2023. When interviewing began in February of 2023, the committee met 2-3 times weekly. We fortunately had several candidates interested in our Profile. After carefully considering all applications, and interviewing several over Zoom and in person, the committee unanimously chose Andrew Harris as our choice for candidate for our Settled Pastor.

On June 25, 2023 our church held a Candidating Weekend at which Andrew was invited to give the sermon and came before the congregation for a vote. Once again by unanimous vote, the congregation supported Andrew in becoming our next Settled Pastor. Happily, Andrew began his work with our church in September 2023!

#### DEACONS COMMITTEE 2023 ANNUAL REPORT

Appropriately, the Deacons spend most of their time fulfilling the responsibilities listed for the Board in the church's Constitution. These include all forms of corporate worship, the care of members and friends of the parish and the development of fellowship programs, which includes attracting potential new members, the administration of church communications, and public relations with the community at large.

Deb Glancy left the Deacons in January after many years of outstanding service and leadership as chair of the Board. The decision was made to split the duties of Chair among the remaining members.

At many meetings, the Deacons work with the pastor to plan upcoming special services, such as Ash Wednesday and Holy Week services, Mother's and Father's Days, and Children's and Special Music Sundays. During Easter, Thanksgiving and the Advent/Christmas season the Deacons appreciate everyone who assists us in decorating, adding to the warm and welcoming spirit of our sanctuary.

Special coffee hours were planned to recognize Brian Gionet's arrival as Director of Music Ministries, Lynn and Lee Tirrell's retirement from the choir after a combined 121 years of participation, Interim Pastor Ed Koonz's departure, new Settled Pastor Andrew Harris' arrival and Brian's marriage to Alli Donais.

Andrew's arrival brought much energy and many ideas for church activities. This resulted in the creation of a handout of events and renewed publicity efforts, which has drawn new people to events.

One important role of the Deacons is to oversee our Music Ministries and the Special Music Funds, which assist in providing Special Guest Musicians and our music events. We would like to thank the congregation for their continued support, allowing us to be blessed with this beautiful music.

The Deacons delivered plants at Easter and Christmas to people who are largely home bound or have had recent losses or illnesses. The Called to Care committee remained very active and important throughout the year, making in-person visits, calling those who were sick or feeling isolated, providing meals if needed and sending supportive cards to people in need, including monthly cards to 15-20 people. When an unexpected illness or death occurred, the Called to Care committee quickly reached out and provided comfort and help when requested. Our congregation is very blessed to be supported and cared by this dedicated group of people. Over the course of the year, there was considerable discussion about practices that had been put in place during the Covid epidemic and whether/how to continue them. These included whether to continue with people picking up their own communion packets on entering the sanctuary or returning to having the ushers distribute communion, and the resumption of full coffee hours on a regular basis as well as the greatly enjoyed Welcome Back Sunday casserole buffet.

#### <u>CRAFTERS FOR A CAUSE - C4C</u> <u>2023 ANNUAL REPORT</u>

Thursday afternoons around 1PM you will find a group of interesting, happy, creative people sitting in a circle making items that are given away to support people in need. During the winter we have a hybrid meeting in the conference room allowing some of us attend via zoom. On nice warm weather days, we meet out of doors.

Over a dozen years ago a decree went out from our interim minister that she needed a knitted square for every congregate in attendance and gave us several weeks to fulfill the need. It turned out an amazing number of knitters were ready to take on the cause. They dusted off their knitting needles, got out their yarn stash and made 100 squares. Since those early days we have diversified and now our prayer square basket contains handmade squares, rectangles, triangles, circles and even a few shaped like a cross. We so enjoyed getting back to knitting we agreed to meet regularly once a week. As time passed, we added prayer shawls, Baptism blankets, comfort blankets, hats, scarves, fingerless mitten and ear warmers to our annual projects.

This year 12 **prayer (comfort) shawls** were given to congregates and friends. One member has created a lovely card that accompanies each shawl and says "May this shawl remind you that you are surrounded by prayers of others". We also supply handmade white **baptismal blankets.** There were 2 Baptisms this year and each child was given a blanket. This blanket symbolizes the arms of our church encircling and supporting the child. We supported a local coat drive organized by Rev Harris and the Missions Committee which collected over 70 coats for needy children in the school system. C4C donated over 50 hats, scarves and fingerless mittens that were given away with the coats. Some of those hats also went to the **Cambridge Street Closet** which helps fill the immediate clothing needs of students in our school.

We also donated items to **Cradles to Crayons** whose goal is to provide clothing helps **to fight "children's clothing Insecurity** "in the Boston area. The **Wish Project** of Chelmsford also received items from us, their goal is to "provide our local (Lowell area) people in need with basic furniture, home goods and baby goods, while helping the planet by recycling used goods." We gave both organizations baby sweaters, blankets and hats.

**Project Linus** "provides handmade blankets to children 0-18 in the United States who are seriously ill, traumatized, or otherwise in need." We gave 10 blankets to Project Linus. We are currently working on 6 more blankets.

In October we worked at the Pumpkin Patch on three Thursdays. The money made, \$5,472.37, was used to help fill the Thanksgiving baskets distributed by People Helping People.

While our crafters find many ways to keep busy, we are blessed to have people who are not able to come to our gatherings but make and donate handmade items to us. Over the years they have donated prayer shawls, baptismal blankets, scarves and hats. While we don't see these people in person, we are grateful for every item donated.

It's not possible to count the number of stories and knowledge shared, the laughter created, and the relaxing mood that many of us experience during our gatherings. We do love the fun-loving creative hours spent together and will continue to meet either in person or via zoom.

All are welcomed to join our gatherings.

# BOARD OF MISSIONS 2023 ANNUAL REPORT

We continued to be a 5 for 5 church in 2023. In the financial section of this report, you will find a listing of the 21 organizations we supported, all special offerings and the disbursements we made to support the UCC at the local and national level.

While we continued to support the international work of the UCC through One Great Hour of Sharing, Church World Service, Tool Sunday (Blanket Sunday) and Neighbors in Need we set a goal to increase our support of local organizations through donations and volunteer efforts. All monetary support is listed in the financial report. In addition to monetary support many volunteers spent hours of their time helping The Community Pantry, The Wish Project, and People Helping People. Along with our monthly red wagon donations of food, the collection of clothing through the annual Pajama Drive, working at the annual Pumpkin Patch, the Wish Tree and helping distribute over 100 Thanksgiving Baskets of food are more examples of the generosity of our congregation. One new project this year was supporting Burlington school age children with a coat drive where we collected and distributed over 70 coats and hats to school age children housed in Burlington. Following the disastrous fires in Maui, we had a special collection to support the work of the UCC there.

In 2024 we plan on asking for the following special offerings with a reminder the Easter and Christmas offerings are divided into two with one half going to the Church and the other to another cause. However; this year the Board of Missions decided to give the entire Christmas offering back to the church. As of January 2024, that an offering of over \$8,000. Additional special offerings are: One Great Hour of sharing (winter), Tool and Blanket Sunday (spring), and Neighbors in Need (fall).

In September the Board of Missions and the Green Team brought in Rev. Dr. Jessica McArdle. Rev McArdle led a service focused on Climate Change and what we can do to be more aware of how our daily activities contribute to this issue.

While what UCC Burlington does may seem small in comparison to the natural disasters we read about and the numerous wars and signs of hostilities between nations, we need to remember that a bucket is filled with water one drop at a time. The Board of Mission is thankful that we are budgeted money each year to support organizations which strive to make our world a better place for all. As we hear at the beginning of the Sunday Service each week "We strive to respond to the needs of our town and world with practical deeds of love".

The Trustees had a busy year that included both major and minor projects. As noted in previous reports from the Trustees, as our facilities age, the Trustees were faced with a multitude of major issues along with typical maintenance. Major issues are presented below. As always, minor ones are too numerous to mention.

#### **Sanctuary Building**

- Installed air purifier in Skelton Hall
- Installed a mesh network to replace the Wi-Fi repeaters.
- Planted new tree by the bench in front of the church.
- Assisted with pollinator garden set up.
- Rebuilt toilet controls in downstairs boys' bathroom.

#### Interconnect

- Responded to flooding in Montessori classroom in the interconnect building. Coordinated with the school to replace wall board and insulation along outside wall.
- Replaced gutters on the north side of the building.
- Regraded lawn on north side of the building
- In the Fall, cleaned gutters.
- Installed new, locking mailbox.
- Installed LED dimmer switch in conference room.

#### **Education Building**

- Repaired bathroom stall door.
- Replace kitchen sink faucet.
- Painted ceiling. ReVision (our solar panel company) paid for the cost of painting the ceiling.

#### **Parsonage**

- Cleaned up downed tree in the backyard.
- Repaired oven controls.
- Prepared the parsonage for the new minister and family.
- Gutters reattached to the house and flashing was installed in the Spring.
- In the Fall, cleaned gutters.

#### Lawn Care

- Hired James Martin Landscaping to care for our lawn.
- Had three dead trees removed from the area adjacent to the parking lot.
- A pollinator garden was created.

#### **Miscellaneous**

- Conducted a Spring clean-up day. Boy Scouts were helpful, however, few parishioners participated.
- Signed snow removal contract with Bob Cuccio.
- Continued to replace burnt out fluorescent light bulbs with LED light bulbs.
- Installed a Nest thermostat to control the office air conditioner. All church thermostats have now been converted to Nest thermostats.

#### **Safe Church Committee**

Attended day-long presentation by Burlington Police Department on church safety.

#### Safety related items

- Annual inspection of fire alarm system turned up a couple of minor issues that were corrected.
- Annual inspection of church boilers turned up a couple of minor issues that were corrected. Passed subsequent inspection.
- Central fire alarm station is starting to show its age, requiring calls for repairs. Fire alarm technician recommended the station should be replaced with a new unit. Have a quote for \$6420 for a new station.
- Replaced battery and pads for defibrillator.
- Sinkhole in front of Ed Building was filled in.
- Electronic lock system malfunctioned a couple of times which required service calls to fix.

We do not accomplish these things without help (although more help would be appreciated). At the extreme risk of forgetting someone, the Trustees would like to thank:

- Bobbie Killilea for being the rental coordinator and the contact person for our vendors.
- Steve Landry for keeping the church clean.
- Everett Langley and John Heald for donating and installing mesh network equipment which improved the wi-fi coverage within the church.

The Green Team is a committee, which is dedicated to improving our planet through eco-stewardship by promoting environmentally friendly practices and efficient improvements.

The Green Team believes that improving and protecting our environment is a practical deed of love to our world. As Christians, we also believe it is our responsibility to be good stewards of this beautiful planet.

#### Year in review:

The Green Team has had a busy and productive year, we met each month to plan goals, activities and events that support our mission to strive to be good stewards of earth and how we can minimize our impact on climate change.

We have worked toward Level 2 Green Congregation Challenge as presented by Southern New England Conference of United Church of Christ (SNEUCC). The Green Congregation Challenge is a step-by-step approach that helps churches take small, but consequential, steps towards protecting God's Creation.

Our Green Team members lead church school on:

- -January 15 Introducing the kids to the amazing skills hummingbirds, snakes and bullfrogs have
- -February 19 For Mardis Gras we had pancakes that the kids enjoyed decorating themselves and coloring their lent path posters.
- -April 19 Lesson was "A Prayer for the Earth, the story of Naamah, Noah's Wife" by Sandy Eisenberg Sasso

On Earth Day Sunday, April 23 Chris Stahlinski presented a sermon on "Sowing Seeds"

Bible Study on creation was led by Rev. Ed Koonz in January and February

Our January theme focused on reduce/recycle/rethink

- -Bike rack: we worked on acquiring a bike rack to be installed at Simons Park by the basketball court. The Rotary Club of Burlington helped fund the purchase of the rack for us. Blessing of the rack is to be held around Earth Day 2024
- -Rain barrel was considered for use at the church, it was not a good fit and it will be used at the parsonage to catch rain water for the watering of the garden there.

In February our theme was soil:

- -On the Green Team bulletin board there was posted two suggested documentaries "Kiss the Soil" and "The Biggest Little Farm"
- -We encouraged composting with details for Black Earth composting offered in Burlington
- -A Lent calendar was created and shared with the congregation in inspire "green" activities during the 6-week lent season. LENTEN THEME: was water, soil, air, sun, food, energy.

On March 26 a Cookie Appreciation was hosted during coffee hour with lots of great cookies made by the congregation were served. We also shared our bounty with the Burlington Fire Department which they appreciated.

In the spring we started planning for a pollinator garden to be installed behind the church sign in front. The work started with planting seeds with the congregation and kids to bring awareness to why it is important to have pollinator plants to nourish bees and butterflies. We received a lot of help and support from Missions, Christian Education and Jim Martin for clearing the area and preparing the soil for planting.

In May the garden was installed with a blessing held on June 11. A watering schedule was created to ensure the garden would thrive and mother nature certainly helped out with the watering.

During coffee hour a Farm Bill was presented where people were able to sign the petition.

The Green Team hosted during church school a session to build bee homes for the kids to take home and place in their yards.

During the churches MINI FAIR- we had a table designated for environmentally friendly items, where people could learn more about sustainable products, buy and donate to the pollinator garden.

We made a shift to use Fair Trade coffee and sustainable products. Woking to eliminate one time use cups, using ceramic mugs for coffee hour

Reached out to the Finance Committee to review divestment of church funds from fossil fuel and other environmentally sensitive investments.

All church lighting has been replaced with LED lights.

On December 3 we hosted our second annual sustainable ornament making class during Coffee Hour. It was well attended, there was lots of fun and creativity.

There are many others that have contributed with donations and their time to make all these events, initiatives possible, thank you to all of you.

# UCC BURLINGTON ENDOWMENT FUND 2023 ANNUAL REPORT

The Endowment Fund increased in value in 2023 with fixed interest gains of \$1,652.88 and net market investment gains totaling \$31,799.12. The total account value at year end was \$418,504.60. The stock and bond mutual fund portfolio net rate of return was +10.57%

The approximate asset allocation in the Endowment Fund is as follows:

4.5% Cash

16.1% Fixed-Term Investments

79.4% Stock and Bond Mutual funds

Our cash account is held with Citizens Bank. One maintenance deposit of \$10.00 was made during 2023 to avoid a monthly "Services Charge Dormant Account Fee" of \$5.00.

At the end of year 2023, the total due Endowment was \$6492.34.

The Endowment Fund is intended for the long-term support of the church. Our goal is to grow this fund so that its interest earnings can be used to supplement our church budget. A gift of any size, at any time, to the Endowment Fund is an excellent way to invest in our church's future.

#### **GIFT CARDS**

This was the 11<sup>th</sup> year that Nancy Todd has been the coordinator of our "Gift Card" fundraiser. Time for somebody else to step up, PLEASE!

In 2023 **nine** different families placed orders for Gift Cards totalling **\$7,365 f**or which we received a total rebate of \$323.96.

Again this year, most of those orders were reloads or printable gift cards paid by PrestoPay, so they did not incur any shipping charges or require any effort on Nancy's part. She is very grateful to those folks who on their own are using the gift card system to profit the church – thank you! This is a fabulous "win/win" for us – purchasing of gift cards from businesses that you patronize on a daily/monthly basis with a portion of the denomination of that gift card going back to the church at no (or extremely little) cost to you. These cards can be in the form of a plastic "debit" card or "electronic paper" script or the "reload". All one needs to do is get in the habit of buying the gift cards on a regular basis. The "reloads" and electronic cards can be purchased anytime (without waiting for a batch order from the church) if you have set up a "presto pay" account with RaiseRight (formerly ShopwithScrip). If you prefer not to do financial transactions online, you can place your order online at any time and then write a check to the church. Your order will be effective as soon as you get the check to the church office! It makes all the sense in the world to buy your grocery, coffee, department store, hotel or restaurant gift cards through the church program and do your shopping with gift cards. So the church benefits, regardless of where you are living, or vacationing!

A special shout out once again goes to Deana Tredeau, our biggest earner in the gift card program for many, many years now. She regularly refills her cards online, and a portion of all her grocery shopping money goes automatically to the church. **Thank you, Deana!** 

Go to RaiseRight.com to learn all about how you can get involved. Or talk with Deana – she's our resident pro! And PLEASE consider seriously if you are at all interested in helping with (or just taking over) the coordination of this program for the church. It is a badly underused opportunity to raise funds.

#### **CHARCUTERIE CLASS**

This was our first time holding a class of this type. We have a great turnout from church people, and folks who saw our advertisement on the PATCH. It was a deliciously, wonderful event. Thank you to our volunteers who helped make it such a nice time. We raised \$1,580 for our church.

#### PLANT/BAKE/CRAFT SALE

#### **ONLINE AUCTION**

The on-line auction is the church's largest fundraiser as well as being fun event. We had a variety of goods donated from companies, restaurants, retailers around town, time shares, as well as goods from some of our members. We raised \$8,148.02. We were pleased that a large portion of people outside our church family bid on items.

#### BOARD OF FINANCE AND STEWARDSHIP 2023 ANNUAL REPORT

At the annual meeting in February 2023, the congregation approved a \$23,164.16 deficit budget for the year.

In addition to starting the year with a fifth consecutive deficit budget, the Finance and Stewardship function started out 2023 with two (2) members (The Financial Secretary is considered a voting member, but essentially works **for** the Board.). Julie Lewis and Sally Willard were elected to the board at the annual meeting.

Finance and Stewardship is essential to the operations of a congregation as it runs the annual stewardship campaign, solicits the donation of time and talent commitments, and works with the Treasurer to document the church's income and expenditures against the church budget. Finance and Stewardship facilitates the coordination of the annual budget, which is reviewed and approved by Parish Council and the congregation.

During this year's stewardship campaign, Pastor Andrew Harris spoke about stewardship and the Church. He asked members of our Church to speak to what drew them to and keeps them returning to UCC Burlington. Again, this year we were unable to host a Finance and Stewardship luncheon and activity.

This year's stewardship theme was "Because of You our church changes lives." Julie wrote the theme related stewardship campaign letter included in the stewardship packets. They were distributed on October 22, Stewardship Sunday.

Time and Talent submissions were better than last year, but still well below pre-covid years. This means many of our boards; committees and essential roles will be understaffed or in some cases empty in 2024. In addition, as of writing this report on January 22, 2023, we have received 67 pledges providing about 86% of the necessary funds to balance the budget.

Parish Council will be submitting a deficit budget at the 2024 Annual Meeting again.
